

CARBON REDUCTION PLAN GUIDANCE

Notes for Completion

Where an In-Scope Organisation has determined that the measure applies to the procurement, suppliers wishing to bid for that contract are required at the selection stage to submit a Carbon Reduction Plan which details their organisational carbon footprint and confirms their commitment to achieving Net Zero by 2050.

Carbon Reduction Plans are to be completed by the bidding supplier entity and must meet the reporting requirements set out in supporting guidance, and include the supplier's current carbon footprint and its commitment to reducing emissions to achieve Net Zero emissions by 2050.

The Carbon Reduction Plan should be updated regularly (at least annually) and published and clearly signposted on the supplier's UK website. It should be approved by a director (or equivalent senior leadership) within the supplier's organisation to demonstrate a clear commitment to emissions reduction at the highest level. Suppliers may wish to adopt the key objectives of the Carbon Reduction Plan within their strategic plans.

Emissions reduction targets


To ensure we progress and achieve our goal of Net Zero, we have adopted the following carbon reduction targets.

Scope 1 = 250397 kgco2 / 30% reduction

Scope 2 = 84868 kgco2 / 10% reduction

We project that carbon emissions will decrease by 20% over the next three years to 2025 based on 2020 baseline. We project that carbon emissions will decrease over the next five years to 316405 kgco2 by 2025 (Scope 1 & 2).

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 20**20** baseline. The carbon emission reduction achieved by these schemes will be in effect when performing the contract.

Heron Bros has implemented a net zero strategy to challenge the business to reduce emissions and achieve net zero by 2030. We recognise our responsibility to eliminate and to reduce our emissions over the coming years in line with our targets. These include:

- Implementation of IS14001:2015
- Investment in ESG / sustainability reporting software
- Full carbon audit to understand emissions
- Compliance with ESOS and SECR Regulations
- Production of carbon itinerary across scope 1, scope 2 and scope 3 emissions
- Carbon Reduction Plan produced outlining targets to be achieved across the business
- Project Carbon Reduction Plan implemented across projects
- Monitoring, measuring and reporting of Scope 1 and Scope 2 emissions
- Aim to increase monitoring, measuring and reporting of Scope 3 emissions (supplier deliveries and waste transport) in 2022
- Installation of biomass boilers at Head Office and Factory
- Installation of LED lighting throughout head office
- EV charge points installed at new head office premises

In the future we hope to implement further measures such as:

- Carbon literacy course to our supply chains
- Signing up to green renewable energy tariff

Declaration and Sign Off
